VENDOR REGULATIONS

NO RAINCHECKS OR REFUNDS

All vendors must be registered with the Market Office and spaces paid for before setting up.

Vendors must provide their own change.

Electrical use is minimal. Concessions must have a quiet generator. See Concession Regulations.

All trash is to be bagged and put into dumpsters. All boxes must be broken down.

All vendors are responsible to insure that they are working within the guidelines of the Department of Health, Ohio Department of Taxation, and any and all other agencies and authorities which may have jurisdiction. It is the responsibility of sellers to insure that they meet all applicable requirements.

Subletting of spots is prohibited. Vendors are held fully responsible for any activity conducted in space(s) reserved in their name.

CONCESSION REGULATIONS

In addition to the Vendor Regulations outlined in this document, the following additional regulations apply to food and beverage concessions. Selling pop, bottled water or other beverages are considered a food concession.

Food Concessions, including baked goods and similar "cottage foods" should contact the Columbiana County Health Department at (330) 424-0272.

You must provide a copy of your Product Liability Insurance in the amount of at least \$1,000,000 with Rogers Community Auction and Open Air Market listed as "Also Insured."

Electrical use is minimal. Food concessions must be self-contained using a generator or similar that does not disturb other vendors or visitors with fumes, noise, or other issues.
